

## 2023 Applicant Qualifications

Application for the 2023 cohort of Yenching Scholars will be open from **August 15** to **November 27**, 2022. Candidates must submit all materials before 12:00 noon (Beijing time) on the deadline. Letters of recommendation must also be received by this deadline.

### *Eligibility*

- Minimum of a Bachelor's degree in any field, or currently enrolled on a degree program awarded no later than August 31 of the year in which they wish to enroll;
- An outstanding academic record;
- Strong interest in interdisciplinary study of China;
- A record of extracurricular achievement, community engagement, social responsibility, and leadership potential;
- English proficiency.

We do not have a strict age cut-off for applicants, but to date, no person over the age of 28 has been admitted to the program. The average age of students entering the program is 23.

### *Application Components*

- Yenching Academy [online application](#) (note that *all* students and alumni of [Partner Universities](#) are required to apply through their universities);
- Personal statement (750 words or less);
- Statement of Research Interest (maximum 1500 words, excluding citations):
  - Should include key research question(s), background to study and/or summary of literature, and study design that could reflect the applicant's academic training. Please note that applicants are not committed to making this proposed project their Master's thesis topic. The Admissions Committee wants to judge how they formulate and write about academic topics.
- Curriculum vitae (maximum 2 pages);
- Official transcript(s)<sup>1</sup>;
- Diploma(s) or Certificate(s) of Enrollment<sup>1</sup>;
- Two academic letters of recommendation (English or Chinese):
  - Peking University will only accept recommendation letters written by **full professors or associate professors** (or equivalent titles).
  - For applicants from the HMT regions, letters must be from professors teaching in the field in which you are applying for (e.g. an economics professor for students applying for Economics and Management). Please use the "专家推荐信" template available [here](#).
- English proficiency demonstrated through one of the following scores<sup>2</sup>:

- IELTS (Academic): Overall 7.0
- TOEFL (iBT): Overall 100
- Cambridge English Scale (Advanced): Overall 185
- Submission of English scores: For IELTS, TOEFL, and Cambridge tests, we will only accept scores sent directly to us from these organizations. Please choose “Yenching Academy of Peking University” as the designated recipient of the scores. For TOEFL, use the institution code: C488.
- TOEFL and IELTS English proficiency tests must be taken after **September 1, 2021**. Currently, we do not accept TOEFL MyBest Scores, TOEFL iBT Home Edition, or IELTS Indicator test.

<sup>1</sup> Candidates whose official university documents are in languages other than English or Chinese must submit copies of both the original documents and certified English translations. This requirement also applies to diplomas issued in Latin. Please ensure that the translation indicates the degree type (e.g. Bachelor’s or Master’s degree).

<sup>2</sup> Native English speakers and students or alumni of an English-taught Bachelor’s degree program are not required to provide English proficiency test scores.

### ***Applicants from the Chinese Regions of Hong Kong, Macao and Taiwan (HMT)***

Applicants holding the below identity documents issued to residence from these regions **must** apply as an HMT applicant:

- For residents from the HKSAR and Macao SAR: ①香港或澳门永久性居民身份证和②《港澳居民来往内地通行证》或《港澳居民居住证》
- For residents from the Taiwan region: ①在台湾居住的有效身份证明和②《台湾居民来往大陆通行证》或《台湾居民居住证》

Applicants from these regions are required to submit **two** online applications, and send the application materials in hardcopy to the admissions office.

## ***Applicants Born in the Chinese Mainland or HMT Regions Intending to Apply as an International Candidate***

Peking University has a regulation pertaining to applicants from the Chinese Mainland and the HMT regions who have previously changed their citizenship and intend to apply as an international student. Former citizens of the P.R.C. and the HMT regions must have switched their citizenship for at least six years before being eligible to apply as an international student. Such applicants will need to provide a non-PRC or non-HMT passport that became valid before April 30, 2017.

Additionally, applicants who were born in the Chinese Mainland and later renounced their Chinese citizenships will also need to provide the following documents to [yca-submissions@pku.edu.cn](mailto:yca-submissions@pku.edu.cn) before **November 27, 2022**:

- A non-PRC passport and/or a naturalization document valid before April 30, 2017, as well as a PRC passport with a “cancellation” stamp;
- A document that proves the cancellation of their record of household registration (户籍) within the Chinese Mainland. This is issued by the police station in which they had their household registration in China.
- Applicants may provide the items outlined in the first point (non-PRC passport, naturalization document, and invalid PRC passport) during the application stage, and submit the household registration cancellation document later in time.
- Note that without the above information, applicants will not be recognized as an international student by the university, leading to ineligibility for admission.

## ***Chinese Language Proficiency***

Chinese language proficiency is not a requirement but is highly valued for the Master’s in China Studies program. Applicants who meet one of the following conditions can be eligible to take Chinese-taught and China-related courses offered in other departments within Peking University:

- HSK 6 test taken after **September 1, 2021** and with a test report of: 1) a total score of 210 or higher; and 2) a score no less than 65 for writing;
- Completed a full-time degree program of which the Chinese language was the only language of instruction. Note that applicants will need to provide documentation from the university to certify the language of instruction.

## Cooperating University FAQs

### 1. What is the role of Cooperating Universities?

Cooperating Universities serve as a point of contact for candidates, providing information about the Yenching Academy. Students and alumni of Cooperating Universities should apply directly through the Yenching Academy admissions portal. Additional resources for Cooperating Universities are available [here](#).

### 2. What is the application deadline?

Recruitment deadline for international candidates for September 2023 enrollment is **November 27**, 2022. The application deadline for candidates from the HMT regions will be announced later in time via the [Graduate School of Peking University website](#).

### 3. What steps will Yenching Academy take after receiving applications?

We will contact candidates directly to schedule interviews from December to March. International candidates can attend interviews online or in person at Peking University. All Chinese candidates, including those from the HMT regions, must attend interviews in person. Finalists who are not required to attend interviews in person will receive an invitation email approximately one week before the interview date.

Please note that Peking University will be on winter vacation from January 7 to February 19, 2023. During this period of time, no interviews will be scheduled.

### 4. When can applicants expect decisions?

We will make some acceptance offers on a rolling basis for those we are certain fit our requirements and geographic diversity guidelines for international students (approximately 30-35% Europe, 25-30% U.S. and Canada, and 30-35% rest of the world). Most decisions will be made around April.

### 5. What qualities should a Yenching Scholar possess?

We seek talented, high potential individuals whose collective diversity will create a rich learning and living environment. The best way to understand what we look for in candidates is to review the bios of previous scholars, available on our [website](#). Note that candidates should have a strong interest in China, but we do not require that they have Chinese language study experience. Please review our *Applicant Qualifications* for more information.

## **6. What are the supplemental procedures for candidates from the Chinese regions of Hong Kong, Macao, and Taiwan (HMT)?**

In addition to applying on the Yenching Academy admissions portal, candidates from the HMT regions are also required to submit a supplementary application through the [Peking University Graduate Admissions website](#) (the opening and closing times of the Peking University Graduate Admissions website will be announced via the Graduate School of Peking University [website](#)). As part of the university application requirement, they should mail hard copies of corresponding application materials to the Yenching Academy (Office 116, Jingyuan Courtyard 3, Peking University, No. 5 Yiheyuan Road, Beijing, China, 100871) before **February 19, 2023**.

Please note that applicants holding identity documents issued to residents of these regions **must** apply as an HMT applicant. Failure to complete the Peking University Graduate Admissions application will result in incomplete and unsuccessful application to the Yenching Academy.

## **7. Are Chinese passport holders eligible to apply?**

Mainland Chinese applicants apply through a different process. We are currently only able to accept application from Mainland Chinese students (PRC passport holders) who are currently enrolled as an undergraduate in a Mainland Chinese university. This requirement does not apply to students from the HMT regions.
